1. FOR POSSIBLE ACTION: TO APPROVE TRANSFER OF CLASS II FBO STATUS OF CARSON AVIATION SERVICES, LLC LOCATED AT 2640 COLLEGE PARKWAY AT THE CARSON CITY AIRPORT TO CONDUCT IT'S AIRCRAFT MAINTENANCE AND AVIONICS BUSINESS FROM ITS CURRENT OWNER STEVE POSCIC TO NEW OWNER BETTY CREEKS. (B. Creeks)

Staff Summary: Troy and Betty Creeks have acquired Carson Aviation Services, LLC from Steve Poscic and will continue to provide aircraft maintenance and avionics services at the Sterling Air, ltd. Hangar. Ms. Creeks is seeking approval as a Class II FBO.
