#### F. PUBLIC HEARINGS

1. BRIEFING BY KOHN & COMPANY, LLP, THE CARSON CITY AIRPORT ACCOUNTING SERVICE ON THE STATUS OF THE FY 2016/2017 BUDGET. (B. Kohn)

Staff Summary: The CCAA has requested that Beth Kohn, Kohn & Co. LLP brief the status of the airport budget and the outlook of the budget for the 2016/2017 fiscal year.

2. FOR POSSIBLE ACTION: TO APPROVE A BUILDING AND HANGAR NUMBERING SYSTEM TO ASSIST CARSON CITY WITH ADDRESSING FOR EMERGENCY SERVICES. (T. Rowe)

Staff Summary: The Authority has previously met with representatives of the Carson City Fire Dept. and mapping personnel to develop an addressing system for hangars on the Airport to allow emergency service response to the correct hangar. After holding meetings and working through different numbering systems, it appears that the system

that would best achieve a unique numbering system and avoid disruption of current hangar numbers, would be to identify the building with alpha-numeric values and then use the existing hangar numbers that appear within the developed hangars. The map being presented by Staff accomplishes this goal, and could be provided to the Carson City Fire Dept and Sheriff's dispatch to assist with emergency calls.

3. FOR POSSIBLE ACTION: TO AUTHORIZE THE AIRPORT MANAGER TO INSPECT THE CARSON EXECUTIVE HANGAR CONDOMINIUM ASSOCIATION HANGAR (H-43) IDENTIFIED BY THE FAA AUDITOR AND CONDUCT THAT INSPECTION PURSUANT TO AUTHORITY APPROVAL UNDER CCMC 19.02.020.350(7)(h)20. (T. Rowe)

Staff Summary: The FAA Auditor identified a hangar that had boxes and other items blocking access of the aircraft located in the hangar and observed questionable electrical wiring. This was identified in the FAA Land Use Inspection Report by the Auditor with a compliance request that the Airport Authority follow-up with corrective action. The Airport Manager has indicated that he intends to bring a member of the Carson City Fire Department with him to assist with the safety evaluation and corrective action. Under CCMC 19.02.020.350(7)(h)20, such inspections may be made either if there is an emergency or if the Authority approves the inspection. This item requests Authority approval for the inspection.

4. FOR POSSIBLE ACTION: TO APPOINT A COMMITTEE TO RESEARCH AND COLLECT INFORMATION AND REPORT TO THE AUTHORITY ALL INFORMATION SO THAT THE AUTHORITY CAN EVALUATE ESTABLISHING A HANGAR POLICY AND INSPECTION PROGRAM THAT SATISFIES THE FAA REQUIREMENTS AND MEETS THE NEEDS OF THE AUTHORITY. (T. Rowe)

Staff Summary: The FAA Auditor requested that the Authority establish a hangar inspection program to prevent unapproved non-aeronautical uses of hangars and to assure compliance with the FAA Hangar Use Policy. CCMC Title 19 already contains provisions requiring aeronautical use and a program for hangar inspections. The FAA Hangar Use Policy issued in July 2016 states that ancillary storage of non-aeronautical items is permitted so long as the primary use is the storage of aircraft. The Committee will collect information and present that information to the Authority to enable the Authority to decide whether or how modifications should be made to Title 19 as regards hangar inspections. This Committee will have less than a quorum of Authority members and will be limited to data collection and fact-finding. The Committee shall not limit options or reject facts, but rather collect the data and return it to the Authority so that the Authority can make recommendations and deliberate in a future open meeting.

5. FOR POSSIBLE ACTION: TO PROPOSE AMENDMENTS TO CARSON CITY MUNICIPAL CODE CCMC 19.03 THROUGH-THE-FENCE (TTF) AIRCRAFT OPERATION TO UPDATE THE FEE AND (1) SET A DURATION OF THE PERMITS TO BE 5 YEARS, AND RENEWABLE, (2) RESTRICT ASSIGNMENT OR

SALE OF AT TTF PERMIT WITHOUT EXPRESS PRIOR WRITTEN CONSENT OF THE AUTHORITY, AND (3) REQUIRE SUBORDINATION OF THE PERMIT TO THE FAA GRANT ASSURANCES (S. Tackes)

Staff Summary: The FAA Auditor requested that the Authority require the above 3 conditions on each TTF permit. Since all such permits are required to comply with CCMC Title 19, amending that code is the most efficient way to require these conditions. Currently, the fees in Title 19 are based on 2001 operational costs of the Airport. The new fee will be based on current costs, and will amend CCMC 19.03.060. Currently Title 19 does not specify a duration of the permit. As proposed, the duration will be 5 years and may be renewed by the Authority. Currently, Title 19 provides for a transfer under certain conditions but does not require additional Authority approval. The new provision will require Authority approval. Currently, the Permits require the Permitee to comply with all FAA requirements and not take any action that would interfere with FAA compliance. As proposed the new language will also expressly state that the permit is subordinate to the FAA Grant Assurances.

6. FOR POSSIBLE ACTION: TO APPROVE THE UPDATED AIRPORT LAYOUT PLAN (ALP) PREPARED BY THE AIRPORT ENGINEER. (T. Rowe, S. Tackes, B. Fitzgerald)

Staff Summary: The Airport Engineer has updated the ALP to depict the Through-the-Fence operators and their access points. The Airport Engineer has also added a column to the legend table on the Exhibit A property map that references the corresponding Airport Improvement Project (AIP) grant that was used for the property acquisition. This information had been provided to the FAA Auditor but he has asked that it be added to the Exhibit A property map. Once approved, the Airport Engineer will work with the FAA Airports Division Office planner to integrate the updates with our upcoming Master Plan project.
