1. Contact USA North to locate all underground public utiltiles

2. Transport 53,000lb track excavator to airport site via lowboy haul

3. Transport Loader Backhoe to site

4. Transport Medium Track Excavator-13,000lb to site

5. Transport 24 ton end dump/tractor to site

6. Transport hammer and hand tools to site

7. Identify and terminate building utilities

8. Re-route domestic water feed line to sustain feed to east building

9. Maintain electrical meter and electrical feed to other facilities (may be through temporary support to meter wall. Customer will be required to contract with electrical contractor to provide permanent solution to feed secondary power to other structures)

10. Pipe natural gas line to maintain feed to west buildings

11. Maintain 500 gal buffalo water dust control pump trailer on site during all operations to keep dust and construction FOD control at airport site until operations complete

Demolish block, wood, and composite roof 90' x 50' structure

12. Remove roof structure, load, and haul off site to landfill, estimate five end dump loads – $50\ \text{tons}$

13. Demolish and remove vertical wall structure, "dirty block", most of separated material – Estimate 12 end dump loads, 264 tons

14. Cut and remove all steel and vertical standing structure and debris down to existing concrete slab level. All flat ground floor level concrete, sidewalk, and asphalt to remain. JGE not responsible for potential stress cracking and fractures which may occur during demolition operations

15. Remove all internal plumbing, fixtures, cabinetry, piping, HVAC equipment, and other fixed furniture and demolish and haul off site

16. Site to be scrubbed clean and free of debris to slab level

17. Remove and haul heavy equipment off site
